District 16 ACBL Treasurers Report Quarter 1, ending March 31, 2024

Attached are the Statement of Financial Activities for the three months ending on March 31, 2024, and the Statement of Financial Position depicting the financial condition of District 16 as of March 31, 2024.

Operations incurred expenses in excess of revenues by \$4,693.

Revenues include the Lone Star Regional sanction fees and NABC surcharge, as well as the March STaC tournament. STaC fees due to D16 totaled \$5,805, less \$5,009 that we paid to ACBL, for a net surplus of \$796. We also received a \$250 donation from the Denton Bridge Studio, to be used to support our education efforts.

Expenses include the Best Practices Workshop fee of \$2,500, Scorecard Contractor costs of \$1,500, Website Contractor fee of \$1,000 (for Sergio's start-up costs), Lecture Series fees of \$1,000 (\$400 of which was for 2023), and other minor expenses.

Grass Roots expenses include stipends paid to NAP participants of \$3,700, a \$1,000 subsidy to Unit 172 for hosting the NAP, and \$150 to cover the ACBL membership dues for the students who played at the LSR.

As of March 31, 2024, there was \$4,546 in the Frost Bank checking account, and an additional \$153,027 in an interestbearing Vanguard account, for a total of \$157,573. We also have accounts receivable of \$6,725 (much of which has already been collected in April). These balances include funds that are committed to the Grass Roots Fund (\$24,597), and to future NABCs (\$5,335). They also include Accounts Payable to ACBL for STaC fees of \$5,009, \$800 to NAP winners who have not sent payment instructions, \$809 of 99er game rebates due to clubs from Q1, and \$200 due to lecture series speakers for March.

There is also an account titled Accrued Expenses totaling \$3,777. This appears to be money that needs to be reclassified as STaC Revenue from prior years, but I need to do some more research to be certain.

As evidenced by these financial statements, the District remains in a strong financial position and is in good standing to continue its mission.
